The year 2023 marks the 100th Anniversary of the Hanover and District Hospital Foundation. The Hospital and Foundation were established with the aim to gather the community's generosity and their passion for accessible healthcare in the region, which was evident since the first donation made in 1923. The town's first mayor and a furniture manufacturing entrepreneur, Mr. Daniel Knechtel, made a contribution in memory of his wife, who had passed away. He, along with his son, Mr. Jacob Knechtel, donated their family estate, surrounding grounds, and over \$7,500, to establish "The Hanover Memorial Hospital" and purchase equipment for the facility. Thus, the two men initiated the establishment of the organization that continues to grow and serve the community. The hospital remained at this location for 50 years until the new location was built in 1973 as Hanover and District Hospital. Looking ahead we plan to have a grand celebration Gala, May 27, 2023 as we will celebrate the 100 years of this event!

It does not include any other schedules, the significant accounting policies and notes to the financial statements. Note 2: Excerpts of Summary of Significant Accounting Policies:

The Foundation follows the Canadian Accounting Standards for Not-for-Profit organizations (ASNPO) or Part III of the requirements of the CPA Canada Handbook – Accounting. The General Fund accounts for the Foundation's program delivery and administrative activities. The fund reports unrestricted resources and restricted operating grants and contributions. The Scholarship Fund reports resources that are to be used for the purpose of the Dr. K. Clark and Dr. R. Panabaker Scholarship. The Endowment Fund reports resources contributed for endowment that are not to be expended by the Foundation. The Project Fund reports restricted resources that are to be used for the purpose of the Foundation's current fundraising project.

Note 3: The Foundation has entered into contracts over the next two fiscal years totalling approximately \$54,000.Volunteers contributed about 345 hours in the year 2022 to assist the organizations in carrying out its service delivery activities
